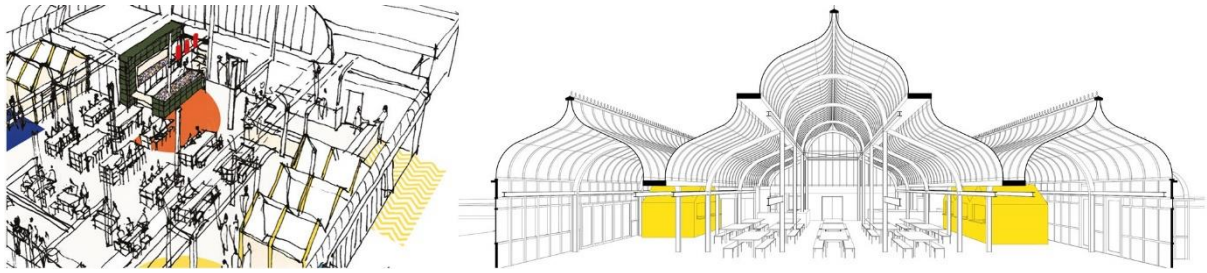

We are looking to hear from start-ups, traders and producers interested in leasing a space for their pop-up business. We will prioritise applications from food, drink and produce traders, but also recognise the need to support all types of local enterprise. If you feel your business is a good fit that presents an exciting offer then please do get in touch.

You will be running your business as part of a wider venture with First Light Festival C.I.C and East Suffolk Council, aiming to put The East Point Pavilion and Lowestoft on the map as a successful and sustainable food and entertainment destination.

We have 5 static trading spaces plus 2 mobile pods available for long- and short-term hire. These will be curated to ensure a good balance and range in terms of food offer and products available, from a mixture of local businesses and those from further afield.

The East Point Pavilion will be opening its doors to the public in 2021 where a range of affordable and flexible rental terms will be available.

Trading hours are subject to Premises Licence approval, but are expected to be between 8am and 11pm.

First Light Festival C.I.C will assess each proposal in accordance with the evaluation criteria which may include, without limitation and in no particular order:

- Quality of the products and services being offered.
- Proof of registration with the relevant local authority.
- Commitment to environmentally sustainable, locally sourced, ethical products, processes, and procedures.
- Commitment to fair and transparent recruitment and management of staff.
- Ability to provide own catering equipment, service ware and experienced, trustworthy, and suitably qualified staff.
- Compliance with the requirements of the Food Safety & Hygiene (England) Regulations 2013, the Food Safety at Work Act 1974 and Fire Regulations.
